The objective of the Core Global Fund is to provide capital growth through low cost exposure to a range of global asset classes. Diversification across asset classes will help to reduce risk and volatility to moderate levels over the medium to longer term.

### Investor profile

The portfolio is suitable for investors seeking low cost global exposure to a range of asset classes as part of their overall investment strategy, with capital appreciation as their primary goal and who do not wish to make complex asset allocation decisions between equities, cash and bonds in global markets. Investors should have a high tolerance for short-term market volatility in order to achieve long-term objectives.

The Sub-Fund employs an active management approach. The Sub-Investment Manager will select collective investment schemes that seek to replicate, as closely as possible, the constituents of the relevant benchmark index, and will do so by holding similar proportions of all of the securities comprising the benchmark index. The Sub-Fund is not managed in reference to any benchmark.

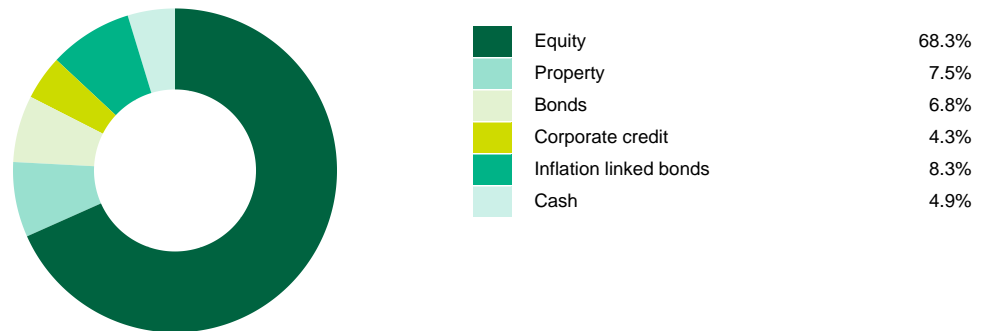

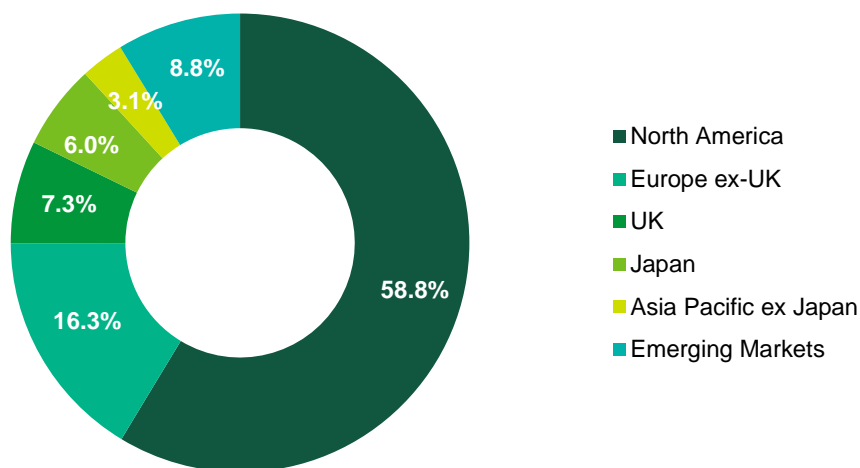
